1 SCOPE

This specification covers the requirements for woven glass fabric that has been cleaned and finished for further fabrication into glass fabric reinforced polyester or epoxy resin parts.

1.1 Classification

The fabric shall be of weave Style 144 (Bay Mills)

2 APPLICABLE DOCUMENTS

The following documents form a part of this specification to the extent specified herein. In the event of conflicting requirements between this and the specifications listed below, the requirements of this specification shall govern. Where a specific issue of a document is not specified, the current issue shall be used.

2.1 Federal Standard 191

Method No. 5030 - Determination of Thickness of Textile Materials

Method No. 5050 - Yarns per unit length in Woven Fabric

Method No. 5104 - Strength and Elongation, Breaking of Woven Fabric, Ravel Strip Method

3 REQUIREMENTS

3.1 Material

The fabric shall be manufactured from continuous filament glass yarn of the highest quality and suitable for the intended purpose. The fibres shall be free from any free alkali metal oxides, such as soda or potash, and from foreign particles, dirt and other impurities.

3.2 Construction and Physical Properties

The construction and physical properties of the finished fabric shall conform to the requirements listed in **Table 1**.

3.3 Dimensions

- 3.3.1 Width Unless otherwise specified, the overall width of the fabric shall be 38" or 50" inclusive with tolerance of \pm 0.25".
- 3.3.2 <u>Length</u> Unless otherwise specified, the overall length of the fabric shall be 200 ± 25 yards. No roll shall contain more than 3 pieces and no piece shall be less than 15 yards in length.

3.4 Fabric Content

The construction of the fabric (Warp and Fill) shall be within ± 2 yarns per inch.

3.5 Finish

The fabric shall be cleaned and treated with a finish which will produce the characteristics required of finished glass fabric in this specification. The finish used on the fabric shall be what is known commercially as Volan "A" and is designated -139 finish by the manufacturer. The methacrylate chromium chloride finish (Volan "A") content of the cleaned glass fabric shall be between 0.02 and 0.06 percent by weight.

3.6 Colour

The colour of the finished fabric shall be uniform and shall be characteristic of the applied finish.

3.7 Workmanship

The finished fabric shall be clean, evenly woven and shall conform to the quality and grade of product established by this specification. The finished fabric shall be free from defects, except to the extent specified herein, and shall be processed as required in accordance with the best practice for a high quality product.

3.7.1 Examination of Cloth

Each roll of glass fabric shall be unrolled so that at least six yards may be visually inspected for defects listed in **Table 2**.

4 TEST METHODS

4.1 Breaking Strength

The material shall be prepared and tested in accordance with Federal Standard 191 Test Method 5104.

4.2 Fabric Thickness

The material shall be prepared and measured in accordance with Federal Standard Test Method 5030.

4.3 Construction

The construction of the material shall be prepared and determined in accordance with Federal Standard Test Method 5050.

5 QUALITY ASSURANCE

5.1 Qualification

- 5.1.1 A supplier is responsible for the performance of all qualification testing, as specified in **Table 3** of this specification.
- 5.1.2 A supplier desiring qualification shall submit one copy of a report showing actual qualification test data and a sufficient quantity of product for de Havilland evaluation tests.
- 5.1.3 Upon review of supplier's data and de Havilland tests, the supplier will be advised either of product qualification or reasons for disqualification.
- 5.1.4 Products that are qualified will be listed in the Qualified Products List of this specification.
- 5.1.5 No changes in the method of manufacture and/or formulation shall be made without notification and prior written approval of Materials and Standards Engineering and Quality Assurance Department of de Havilland Aircraft.
- 5.1.6 Re qualification of the product may be requested by the purchaser if there are any changes in the method of manufacture and/or formulation.

Any product not meeting the requirements of this specification will be returned to the supplier at the supplier's expense.

7 PREPARATION FOR DELIVERY

7.1 Identification

- 7.1.1 Each roll of glass fabric shall be identified with a label or marking, securely affixed to the inside of the core or with a removable tag.
- 7.1.2 The label or removable tag shall use characters of a size such as to be clearly legible and which will not be obliterated by normal handling. Each label or tag shall show the following information:
 - Woven Glass Cloth
 - DHMS F5.04
 - Manufacturer's Material Designation
 - Purchase Order Number
 - Lot and Roll Numbers
 - Quantity
 - Date of Manufacture

7.2 Packaging

The fabric shall be wound on spiral or convolute tubes measuring 2 inches, minimum, diameter and one inch longer than the overall width of the fabric. The roll shall be completely wrapped in a citable weight of draft paper sealed with gummed tape or enclosed in a suitable covering to protect the fabric.

7.3 Shipping Documentation

- 7.3.1 Each shipping container shall have the exterior legibly marked with the following information in such a manner that the markings shall not smear or be obliterated during normal handling or use:
 - Woven Glass Cloth
 - DHMS F5.04
 - Manufacturer's Material Designation
 - Purchase Order Number
 - Lot and Roll Numbers
 - Quantity
- 7.3.2 Containers shall be prepared for shipment in accordance with commercial practice to assure carrier acceptance and safe transportation to the point of delivery.
