

PPS Revision Notice

As of June 1, 2020, the following PPS's have been released, having been revised as noted below:

PPS 9.10, Issue 10 - Standard Wiring Practices for DASH 8 Digital Data Bus

- Replaced throughout PPS where "Bombardier" is specified with "De Havilland Aircraft of Canada Limited" or "DHC".
- Added cautionary notes regarding insulation resistance from Tyco manual.

PPS 9.35, Issue 18 - Terminating and Splicing Aluminum Wires

- Replaced throughout PPS where "Bombardier" is specified with "De Havilland Aircraft of Canada Limited" or "DHC".
- Replaced procedure and requirements for qualification of crimp tools by referring to PPS 9.55 (Qualification of Crimp Tools) for such requirements.
- Specified all testing specified herein shall be performed by DHC Materials Laboratory or a BAERD GEN-018 Rev. E approved laboratory.
- Specified requirements for Arvan Inc. HS20-5435-xx terminal lugs which are interchangeable with MS 25435-xx terminal lugs.
- Specified that there shall be no burrs on lug edges when performing the visual check on crimped MS and Arvan terminals.

PPS 10.25, Issue 8 - Storage and Application of Film Adhesives used in Composite Assemblies

- Replaced throughout PPS where "Bombardier" is specified with "De Havilland Aircraft of Canada Limited" or "DHC".
- Revised Facilities section.
- Specified to perform receipt testing according to the applicable DHMS's batch acceptance testing requirements in place of QAMTR 007.
- Clarified that for subsequent testing of DHMS A6.03 adhesive shall also be to PPS 36.10.
- Specified storage life to be the same as that specified in the respective DHMS's. Specified that material shall be shipped within 90 days from date of manufacture.
- Added new Disposal of Chemical Wastes section.
- Added new Storage section.
- Specified to refer to PPS 13.28 for the storage life of composite materials and products (i.e., DHMS A6.03, DHMS A6.06 and DHMS A6.08).
- Specified to always use the oldest stock first (i.e., first in/first out (FIFO) basis).

PPS 11.10, Issue 6 - Inhibiting and De-Inhibiting of PW120 Series and PW150A Gas Turbine Engines

- Replaced throughout PPS where "Bombardier" is specified with "De Havilland Aircraft of Canada Limited" or "DHC".
- Specified that AN929-(*) and AN929-(*)D are interchangeable with part number AN929-(*)W as per EO7336.
- Added Disposal of Chemical Wastes section.
- Added Storage section.

PPS 16.09, Issue 3 - Fungi Resistant Treatment

- Replaced throughout PPS where "Bombardier" is specified with "De Havilland Aircraft of Canada Limited" or "DHC".
- Added additional Safety Precautions statements.
- Revised personnel requirements to have a good working knowledge of the procedure and requirements in place of just having the basic understanding.

PPS 16.11, Issue 5 - Application of Fuel Vapour Barrier Coating (F35) to Integral Fuel Tanks

- Replaced throughout PPS where "Bombardier" is specified with "De Havilland Aircraft of Canada Limited" or "DHC".
- Specified that all testing and evaluation specified herein shall only be performed by laboratories accredited according to BAERD GEN-018, Rev E.
- Revised personnel requirements to have a good working knowledge of the procedure and requirements in place of just having the basic understanding.
- Added additional DHC safety precautions.
- Added a Disposal of Chemical Wastes section.
- Specified to always use the oldest stock first (i.e., first in/first out (FIFO) basis).
